- XIV. Shorten private investment time to encourage PPP investment
- XV. There should be a mapping system for investment cluster areas of the FCT (FCT GIS)
- XVI. We should have a framework for investment activities
- XVII. There should be Cost implication of each investment cluster aside the actual investment
- XVIII. There should be an export plan in each investment project
- XIX. There should be a frame work for Data collection and optimization
- XX. We encourage 60% local investors to 40% foreign investment in livestock production
